This announcement includes important updates regarding NYSERDA's residential financing applications and the 10.19.16 Financing Webinar.

Residential Financing and Incentive Applications

EFS is now assigning revision numbers on the downloadable applications to help our partners and their customers ensure that they are using the version with the most recent updates. ***Please note that regardless of the revision number, as long as the application includes "9.1.2016" in the version number, it will still be accepted***, as the information collected in the application has not changed. The edits reflected in revisions were to clarify language or instructions, and correct typographical errors. We encourage you to always use the most recent revision.

Along with adding the revision number to the application itself, EFS has removed the revision number from the address of the hyperlinks attached to the applications. This means that going forward, you will not have to edit bookmarks you may have created for the link to the application. Please update your bookmarks now to the current application (revision 5) and delete any old bookmarks.
