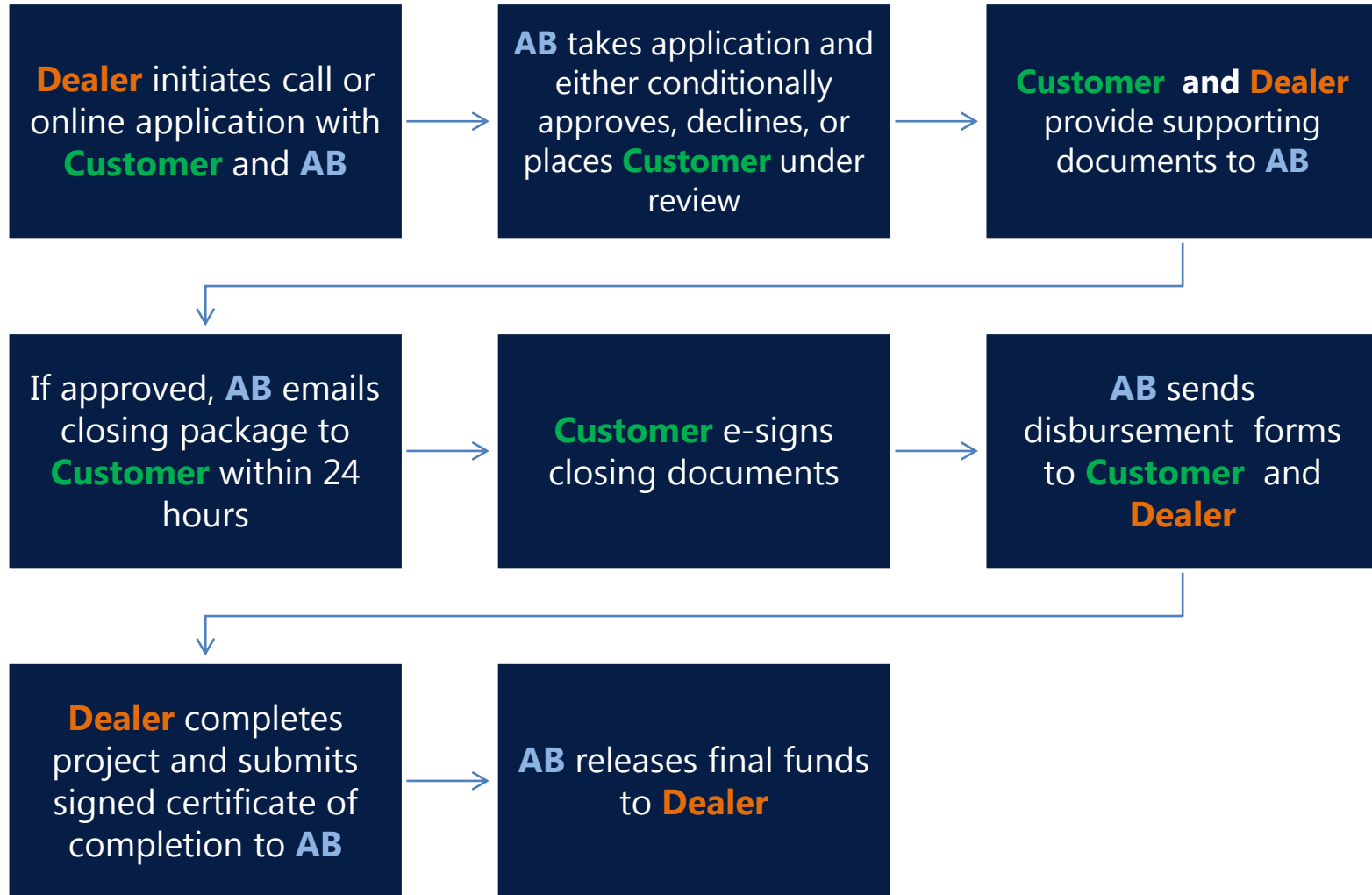
Operational Benefits



- Once a loan has closed, funds are disbursed to the Dealer (net of fees)¹
- Flexible disbursement options available
 - Dealer has the option to receive funds via Wire (by 4:30 PM EST) or ACH (by 3:30 PM EST)
- 120-day construction period. If necessary, 60 day extensions available.
 - Interest only payments during this time period

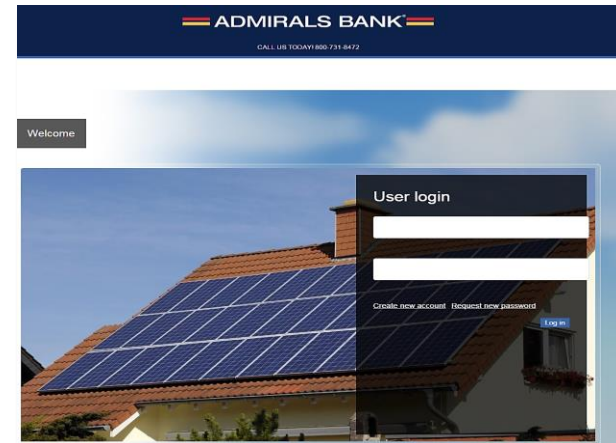
