The New York State Public Service Commission (PSC) and the New York State Energy Research and Development Authority (NYSERDA), in cooperation with the LIFE Steering Committee, are proud to announce the LIFE 2019 Regional Meeting.

Attendees can expect to learn about energy affordability policy, clean energy programs, utility assistance programs, emerging energy issues, innovative models in the low-income energy space, consumer protections, and best practices. The agenda will vary based on location to allow for focus on issues important to a given region.

Additionally, building on the discussions started during the [2018 LMI Public Forums](#), NYSERDA and the NYS Department of Public Service (DPS) will incorporate a stakeholder discussion session into each LIFE Regional Meeting. The discussion will focus on current initiatives and identifying opportunities to improve the impact of energy and affordability programs in communities.

Registration Details

Registration Fee: \$45 per attendee and includes continental breakfast and lunch, refreshments, and conference materials.

Early Registration Discount: Register by April 29 and receive a \$10 discount. Early registration fee is \$35 per attendee.

Group Rate: A special group rate of \$30 per attendee is available for organizations registering three or more individuals.
