



### **Customer Application: Campaign Code Update**

- Customers the number of customers that registered for an account by accessing the Campaign Code link
- **Created** of the customers that registered for an account, the number that started an application
- **Submitted** of the customers that started an application, the number that submitted it to the program for review
- Edit- allows the user to deactivate campaign codes no longer being used
- View a report of applications associated with the campaign code that the user has access to.

### **Pilot Partnership and Objectives**

#### **Partnership**

•The Pilot is a partnership between the New York State Energy Research and Development Authority (NYSERDA), New York State Department of Health (DOH) Office of Health Insurance Programs and Office of Public Health

•Funding through NYSERDA's Clean Energy Fund (rate payer \$) ~\$10M for Pilot implementation and market support (with \$6.1M allotted to fund the in-unit interventions)

#### **Pilot Objectives**

•Develop a framework that allows New York's managed care organizations (MCO)(i.e. health plans) to fund residential healthy homes interventions as part of their value-based payment (VBP) arrangements with healthcare providers within the Medicaid Healthcare Delivery System.

- Demonstrate a residential healthy homes intervention intended to: Improve asthma-related health outcomes
- Reduce energy use, reduce utility bill costs, improve home comfort and safety
- o Reduce Medicaid utilization associated with avoidable hospitalization and emergency department use



#### **Eligibility**

- NYSERDA is seeking Participating Contractors serving the counties listed below who meet the qualifying criteria outlined in the Addendum.
  - Chautauqua County (Western NY)
  - Erie County (Western NY)
  - Niagara County (Western NY)
  - Onondaga County (Central NY)

- Bronx County (The Bronx)
  - Kings County (Brooklyn)
  - New York County (Manhattan)
- Queens County (Queens).
- Richmond County (Staten Island)
- These Participating Contractors shall have the technical and administrative capacity to deliver the dwelling-based services included in the Pilot intervention. Dwelling-based services can be delivered by Participating Contractors or their technically-qualified subcontractors. The full suite of eligibility services is available in the NYS Healthy Homes Value-Based Payment Pilot Addendum.
- NYSERDA anticipates referrals to be provided under this Addendum until June 2024, with all measures being installed by December 31, 2024.

### **EmPower+ Name Change Transition-Update**


- EmPower+ and NYHEP launch date has been moved to July to allow additional time to address any remain technology challenges and ensure an improved crossover experience.



## Individuals Still Requiring Training



### NY Home Energy Portal Individuals Still Requiring Training-Reminder

Individuals that did not attend either an in-person or virtual training must view a training recording and complete the assigned homework to receive NY HEP login credentials. Instructions below outline the steps. No new user\* requests for UAT will be accepted after June 23.To ensure access to the NYHEP at launch, homework must be completed no later than June 30<sup>th</sup>, this will allow sufficient time for staff to activate all users in the system.

- 1. Sign-up by sending your name, company, and email address to tech.updates@clearesult.com
  - Users will receive a welcome email with their log-in credentials on a weekly cadence, links to training video, homework assignment and additional resources.
- 2. View training recording

  - Upon approval, access to the production environment will be provided when the system goes live.

# Home Performance with ENERGY STAR Sunsetting

- 1. DOE has finalized the timeline for the sunsetting of the Home Performance with ENERGY STAR<sup>®</sup>(HPwES) Program. Below are the upcoming milestone dates:
  - December 31, 2023: The final day to produce any HPwES promotional materials using the logo/graphic.
  - Throughout 2024: Sponsors and contractors may continue using the HPwES logo/graphic.
  - December 31, 2024: Use of the HPwES logo/graphic ends.
- 2. DOE will be sending a letter to contractors in the next 30 days with additional guidance and resources. Once available, a copy will be posted to the support site.
- 3. With the transition to EmPower+ in July, NYSERDA is retiring use of the "HPwES" name and logos as part of the program materials. Contractors and partners who use this name and/or logo should cease to do so by the end of 2024.

## **OTDA 2023 Funding**



### **OTDA 2023 Funding**

- OTDA 2023 Funding has been approved and projects with valid HEAP award letters dated October 1, 2022 and later are eligible for the funding.
- These funds will follow the same rules as ARPA and OTDA 2022 funding, but with customers needed to have approved applications by September 15, 2023 and projects completed by September 15, 2024. These rules can be found in the Program Manual:

 There are still over 3,000 projects in contractor's queues that are eligible for OTDA 2022 funding. These projects will need to be completed by September 15, 2023 to receive OTDA 2022 funding. If they are not completed by this day, NYSERDA will have to re-verify that the projects qualify for HEAP funding.
