Required Spray Foam Trainings

Contractor Requirements

- Trainings must be completed before October 1, 2025.
- Contractors are required to keep documentation of all staff that attended the trainings.
 Documentation must include the training title, staff names, and dates the training was completed.
 At NYSERDA's request contractors must submit the training documentation within 48 hours of request.
- Contractors will be required to submit a sign document that their company meets the new training requirements.
